unto Gerald R. Glur and Jean A. Glur, their heirs and assigns forever:

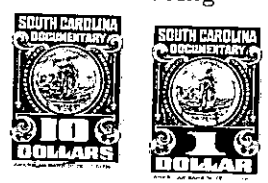

BEGINNING at an iron pin at the corner of Lots 11 and 12 on the southern side of Ike's Road and running thence with the joint line of said lots, S. 10-00 E. 206.6 feet to the rear corner of Lot 19; thence with the rear line of Lot 19, S. 81-41 W. 42.8 feet to an iron pin at the corner of Lot 20; thence with the rear line of Lot 20, S. 80-08 W. 11.3 feet to an iron pin at the rear corner of Lots 10 and 11; thence with the joint line of said lots, N. 21-38 W. 193.2 feet to an iron pin on the southern side of Ike's Road; thence with the southern side of Ike's Road, N. 69-11 E. 95 feet to the point of beginning.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s), or on the premises.
