All that certain piece, parcel or triangular lot of land situate, lying and being in the State of South Carolina, County of Greenville, being the identical property conveyed by the grantees to the grantor by deed dated April 30, 1970, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 889 at page 267, and having, according to said deed, the following metes and bounds, to-wit:

BEGINNING at a point on the joint line of properties belonging to the grantors and the grantee where said joint property line intersects the north side of the right-of-way for By-Pass Highway 291 and running thence along the joint line of said properties, N. 75-34 W. 81 feet to an iron pin; thence S. 21-26 E. 49.5 feet to an iron pin on the north side of the right-of-way for By-Pass Highway 291; thence along the north side of said right-of-way, N. 68-34 E. 64.3 feet to the beginning corner;
