ALL that piece, parcel or lot of land lying and being on the West side of Belvue Road, in Bates Township, Greenville County, South Carolina, and being shown as 1/12 acre of land on that plat entitled Property of Clyde Green and Rex Hawkins, recorded in the RMC Office for Greenville County, South Carolina in Plat Book 4-D, Page 135, and having, according to said plat, the following metes and bounds, to-wit:
