All that lot of land located in the State of South Carolina, County of Greenville, O'Neal Township, about six miles northwest of Greer, on the west side of Meece Bridge Road, containing 29.53 acres, more or less, and being shown and designated as parts of Lots Nos. 5 and 6, and shown on survey of the Estate of Thomas R. Fowler by Terry T. Dill, and revised by W. R. Williams, Jr., R. L. S., September 28, 1970, said plat to be recorded herewith, and having, according to the plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of Meece Bridge Road, corner of Lot No. 5, and running thence along and with Meece Bridge Road, S. 2-47 E. 619.6 feet to an iron pin; thence S. 2-51 E. 180 feet to an iron pin; thence S. 3-34 E. 322.3 feet to an iron pin; thence S. 1-00 E. 750.5 feet to an iron pin; thence S. 64-30 W. 385.5 feet to an iron pin; thence N. 20-40 W. 1129 feet to an iron pin; thence continuing N. 20-40 W. 575 feet to an iron pin; thence N. 3-30 W. 253.4 feet to an iron pin; thence N. 78-10 E. 905 feet to the point of beginning.

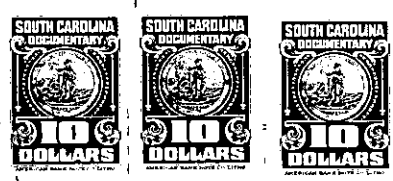

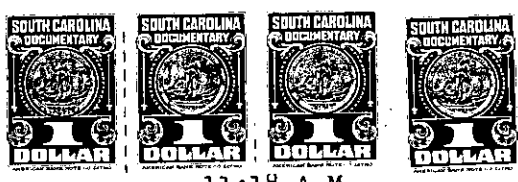
