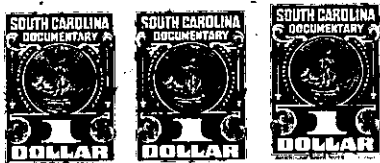
KNOW ALL MEN BY THESE PRESENTS, that We, Alvin E. Smith and George H. Lindsey,
