Whereas, my Mother, Emma C. Gilreath Thompson, died intestate in April 1902, with sole title to within described and other land, leaving sole heirs my Father, James Henry Thompson and myself and he having died intestate in July 1911 and my half brothers and sisters etc., having conveyed to me all of their right, title and interest in and to, of the estate of the said James Henry Thompson, deceased)

All of that certain tract of land in said State and County, O'Neal Township, all of tract No. 4 on a plat of Property of L.E. Thompson, prepared by Terry T. Dill, Reg. Surveyor, dated December 7th., 1967, said plat to be recorded, having the following notes and bounds:
