ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, on Rollingwood Drive, being shown as Lot # 40 on plat of Edwards Forest Heights recorded in Plat Book 000 at Page 89, and being more fully described as follows:

BEGINNING at the joint front corner of Lots 40 and 41 and running thence with the joint line of said lots, South 54-23 West 165.6 feet; thence South 35-22 East 110 feet to the joint rear corner of lots 39 and 40; thence with the joint line of said lots, North 54-38 East 165 feet to the joint front corner of said lots; thence along Rollingwood Drive, North 35-22 West 87.7 feet; thence continuing along Rollingwood Drive, North 33-22 West 23 feet to the beginning corner.
