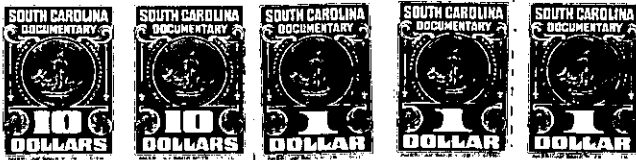
All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Hunting Hollow Road, near the City of Greenville, S. C., being known and designated as Lot No. 113 on plat of Section I, Foxcroft, as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4F, pages 2, 3 and 4 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Hunting Hollow Road, said pin being the joint front corner of Lots 113 and 114 and running thence with the common line of said lots S 42-44 W 271.2 feet to an iron pin, the joint rear corner of Lots 113 and 114; thence N 79-51 E 290 feet to an iron pin, the joint rear corner of Lots 112 and 113; thence with the common line of said lots N 10-09 W 160.9 feet to an iron pin on the southerly side of Hunting Hollow Road; thence with the southerly side of Hunting Hollow Road S 62-52 W 15.8 feet; thence continuing with said Road on a curve the chord of which is S 87-00 W 59 feet to an iron pin, the point of beginning.

This conveyance is made subject to a 25 foot sewer right of way and a 50 feet water line right of way and to all restrictions, setback lines, roadways, easements and right of ways, if any, affecting the above described property.
