ALL that certain piece, parcel or lot of land situate, lying and being in Grove Township, Greenville County, South Carolina, designated as Lot No. 15, Section 1 of Belle Terre Acres, as shown on a plat recorded in the RMC Office for Greenville County in Plat Book OOO at Pages 104-105, said lot containing 1.64 acres, more or less, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the eastern side of West Fairway Drive at the joint corner with Lot No. 16, and running thence S. 78-50 E. 266.9 feet to an iron pin; thence along the curve of East Fairway Drive as follows: S. 10-29 W. 64.8 feet; S. 18-00 W. 66.1 feet; S. 39-20 W. 64.9 feet; S. 48-11 W. 142.3 feet to an iron pin at the corner of Lot No. 14; thence N. 50-28 W. 250.1 feet to an iron pin; thence along West Fairway Drive as follows: N. 42-40 E. 37.5 feet; N. 36-50 E. 112.5 feet; N. 20-45 E. 50 feet to the point of beginning.

THIS being a portion of the property conveyed to the Grantor by a certain deed recorded in the RMC Office for Greenville County in Deed Book 459 at Page 528. The Grantor to pay the 1970 County taxes on said property.
