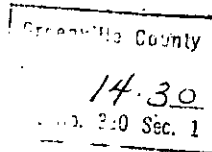
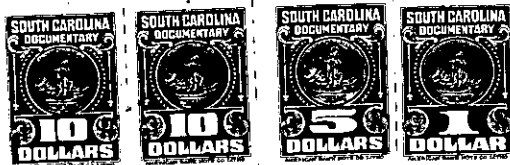
KNOW ALL MEN BY THESE PRESENTS, that Robert E. Richey and Diane P. Richey -----
