the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Harold L. Northway and Carolyn S. Northway, their heirs and assigns forever:

All that certain piece, parcel or tract of land in Greenville County, State of South Carolina, being located on the Easterly side of Moore Road, and being known and designated as Lot No. 1 on plat entitled property of William E. Moore, dated October, 1966, surveyed by Robert Jordan and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a nail in center of Moore Road and running thence N. 45-09 E., 1273.9 feet to an old iron pin in branch; thence with the center of branch, the meander of which is N. 38-03 W., 87.7 feet to an iron pin; thence with line of Lot No. 2 S 53-05 W., 1219.9 feet to a nail in center of Moore Road, passing over iron pin 25 feet back on line; thence with the center of Moore Road, S. 28-08 E., 266 feet to the beginning corner.

ALSO Tract No. 2 as shown on the above referred to plat and having according to said plat the following metes and bounds, to wit:

BEGINNING at a nail in center of Moore Road, which nail is located S. 53-05 W., 25 feet from iron pin on the Easterly side of Moore Road and running thence with the line of Lot No. 1 N. 53-03 E., 1219.9 feet to an iron pin in branch; thence with the center line of branch, the meander of which is N 57-18 W., 116 feet to an iron pin; thence with the line of Lot No. 3 S. 60-46 W., 1149.2 feet to a nail in center of Moore Road, passing over iron pin 25 feet back on line; thence with the center of Moore Road, S. 28-08 E., 266 feet to the beginning corner.
