unto
MARGARET W. SHEPPARD, HER HEIRS AND ASSIGNS FOREVER:

ALL that piece, parcel or lot of land in Austin Township, County of Greenville, State of South Carolina, known and designated as Lot No. 2 on a plat of property of Elles Williams by C. F. Webb, dated May 1970, being bounded on the north by Lot No. 1, on the west by Lot No. 4, on the south by Lot No. 3 and on the east by Thurgood Avenue, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the western side of Thurgood Avenue, joint corner of Lot No. 1 and running thence S. 56-19 W. 242.44 feet to an iron pin; thence along the line of Lot No. 4, S. 35-56 E. 254.4 feet to an iron pin; thence along the line of Lot No. 3, N. 55-32 E. 219.9 feet to an iron pin on the western side of Thurgood Avenue; thence N. 36-25 W. 9.4 feet to an old iron pin; thence continuing with Thurgood Avenue, N. 18-01 W. 80 feet to an iron pin, the point of beginning.

This conveyance is made subject to restrictive covenants of record and to any easements or rights of way affecting same.
