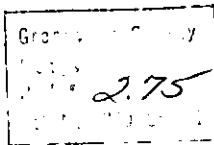
KNOW ALL MEN BY THESE PRESENTS, that We, BRUCE EARL ETRIS and STELLA SMITH ETRIS,
