AND Christ Church Cemetery/does hereby bind itself and its successors to warrant and forever defend the said premises to the said Madeline Haynsworth her heirs and assigns against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof; subject, however, to the restrictions and limitations herein contained.
