the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto

DUNCAN CHAPEL FIRE DISTRICT, its Successors and Assigns, forever:

All of the right, title, interest and estate of the Grantor in and to all that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, containing 2.27 acres, near the intersection of Poinsett Highway and Buncombe Road, on the Northwestern side of Access Road from Poinsett Highway to Buncombe Road, and having, according to a plat made by J. C. Hill, L.S., October 13, 1956, entitled "Property of Frances Raines", recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 48, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Access Road to New Highway No. 25, Poinsett Highway, at joint corner with property of Furman University, and running thence with the Northwestern side of said road the following five (5) courses and distances, N. 38-57 W. 159.7 feet, N. 45-13 W. 126.6 feet, N. 52-15 W. 132.5 feet, N. 53-43 W. 177.7 feet, and N. 50-19 W. 175.6 feet to an iron pin at joint line with Furman University; thence with the joint line with said University, S. 5-11 E. 327.9 feet to an iron pin; thence continuing with the joint line with Furman University, S. 71-26 E. 571 feet to an iron pin on the Northwestern side of Access Road from Poinsett Highway, the point of beginning.

The right, title, interest and estate of the Grantor is an undivided one-eighth (1/8) in a contingent remainder derived from Item 8 of the Last Will and Testament of Frances Madden Raines, on file in the Probate Court for Greenville County in Apt. 699, File 10, and as construed by the Court in an action of record in the office of the Clerk of Court for Greenville County in Judgment Roll H-10, 428. The above described property is a portion of that property devised to Frances M. Raines by her mother, Mamie F. Raines, Apt. 422, File 5, and a portion conveyed to the said Mamie F. Raines by her husband, Joe O. Raines, by deed of record in Deed Book 126, at Page 551.
