BEGINNING at an iron pin on the North side of Dera Street at the joint front corner of Lots 43 and 44 and runs thence along the line of Lot 43, N. 6-00 W. 255.9 feet to an iron pin; thence S. 82-26 E. 56 feet to an iron pin; thence S. 71-14 E. 63 feet to an iron pin; thence along the line of Lot 45, S. 0-52 W. 229.3 feet to an iron pin on the North side of Dera Street; thence along Dera Street, N. 87-53 W. 15 feet to an iron pin; thence still along Dera Street, S. 89-46 W. 70 feet to the beginning corner.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record on the recorded plat(s) or on the premises.

As a part of the consideration hereof, the grantees agree to assume and pay, according to its terms, that certain note and mortgage given to Carolina National Mortgage Investment Company, Inc., on which there is a balance due of \$20,156.12; said mortgage being recorded in Mortgages Volume 1125, Page 445.
