This is the same p; roperty conveyed by W.C. Bramlett to Ellen Poole in 1950, in deed book 406 at page 524; wherein the granting clause, habendum clause and the dower clause were incomplete. This deed is to correct that omission. W.C. Bramlett died testate in 1957 as will appear in Apt 671, file 5, devising said estate to the grantors. The grantors make no claims as to the land conveyed.

Subsequent to the conveyance unto Ellen Poole, she conveyed 2 acres to Daniel B. Burns in deed book 450 at page 336. The grantors quitclaim any interest in said two acres; then she conveyed the balance of said land in A.A. Merrick in deed books 467, page 238 (as 32 acres) and by correction deed in 474, page 131, as 53 acres. A.A. Merrick died testate devising it to his son in Apt 809, file 5, to Anson A. Merrack, Jr.; he subsequently conveyed the property to the grantees in deed book 743, page 78. Emma Cox left her interest to Mary Sue Cox and Sue H. Cox as will appear in Apt 753, file 1. The grantees have conveyed 6.5 acres to Burnis W. and Grace C. Hancock in dedd book 753, page 306; it was reconveyed in 761, page 487, and, then again conveyed to Burnis W. and Grace C. Hancock in deed book 761, page 488.

The grantors release any interest they might have to the property conveyed by W.C. Bramlett to Ellen Poole, as above set forth.
