

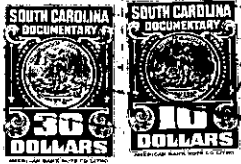

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents  
do grant, bargain, sell and release unto the said Corinne H. Campbell

All that piece, parcel or tract of land containing 44.0 acres,  
more or less, situate, lying and being on the Northern side of Harrison  
Bridge Road, Fairview Township, Greenville County, State of South Caro-  
lina, and having according to a plat prepared by C. O. Riddle, dated  
January, 1971, entitled "Survey for W. Gaines Huguley" and recorded in  
the R. M. C. Office for Greenville County, South Carolina, in Plat Book  
41 at page 77, the following metes and bounds:

BEGINNING at a nail and cap in the center of Harrison Bridge Road at  
the Southwestern corner of the premises herein described and at the joint  
corner of other property of the Grantor herein, and running thence with  
the line of the said other property of the Grantor and with the center  
line of Harrison Bridge Road as the line, the following courses and  
distances: S. 70-54 E. 150 feet to a point, thence S. 83-29 E. 200  
feet to a point, thence S. 82-35 E. 200 feet to a point, thence S. 83-14  
E. 480 feet to a point, thence S. 82-05 E. 315.2 feet to a point, thence  
S. 78-19 E. 200 feet to a point, thence S. 70-17 E. 100 feet to a nail  
and cap, thence S. 61-46 E. 100 feet to a spike, thence S. 60-53 E. 19.3  
feet to a spike; thence with the line of the property now or formerly of  
Putnam N. 31-55 E. 1007 feet to an iron pin in or near a branch; thence  
with the line of property now or formerly of L. J. Vaughn, Jr. and with  
the center line of said branch as the line, having a traverse line as  
follows: West 187 feet to a point, thence N. 72-00 W. 390 feet to a  
point, thence N. 71-45 W. 736 feet to a point, thence N. 71-15 W. 432  
feet to an iron pin in or near said branch, thence with the line of  
the property now or formerly of Leopard, S. 29-24 W. 1155.6 feet to  
the point of beginning.
