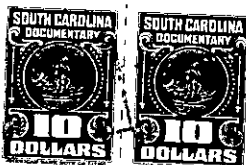
KNOW ALL MEN BY THESE PRESENTS, that Edgar Harbin and Lillie M. Harbin -----
