all of my right, title and interest in the following described real estate, the same being an undivided one-fourth interest in said property;

All of that certain piece, parcel or lot of land with the buildings and improvements thereon in the City of Greenville, County of Greenville, State of South Carolina, near the Laurens Road, on the west side of Lennox Avenue, and having the following metes and bounds, to wit:

BEGINNING at a point on the west side of Lennox Avenue, which point is 150 feet northeast from the intersection of the Laurens Road and Lennox Avenue, and running thence along the west side of Lennox Avenue, N. 34-15 E. 50 feet; thence N. 55-45 W. 105 feet to pin; thence S. 34-15 W. 50 feet to corner of Swygert lot; thence with line of Swygert lot, S. 55-45 E. 105 feet to the beginning corner.

The one-fourth interest of Aziz E. Zoghby in the above described real estate was devised to him by will of Angele N. Zoghby, a copy of said will being on file in the Office of the Probate Court for Greenville County, S. C. C., has ordered that the building on the above described lot be demolished; and it is further understood that the said H. B. Swygert and Kathleen S. Swygert by accepting this deed shall be responsible for demolishing said building at their expense.
