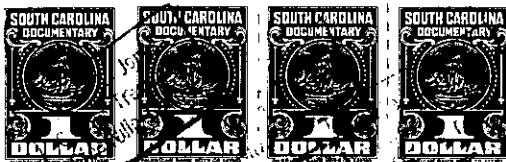

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto STAR ENTERPRISES, INC., the following-described property:

All that piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the east side of Winterberry Court as shown by plat of property of Star Enterprises, Inc., Star Theatres, Inc., and Eight Associates, Inc., prepared by John E. Woods, RLS, dated March 1971, recorded in the office of the R.M.C. for Greenville County in Plat Book 41, page 55, and having according to said plat the following metes and bounds, to-wit:
