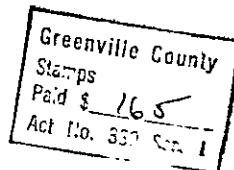
KNOW ALL MEN BY THESE PRESENTS, that We, Theodore V. Howie and Heyward R. McConnell,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto
Ward S. Stone, and Ledger D. Weber, their heirs and assigns forever:

All those certain pieces, parcels or lots of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lots Nos. 7 and 8 of Block A of a subdivision known as Jefferson Heights as shown on a plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book C at Pages 34 and 35, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of First Avenue (now known as Rebecca Avenue), joint front corner of Lots 8 and 9 and running thence with the joint line of said lots, N. 81-40 E. 87.5 feet to an iron pin at the rear corner of Lot No. 33; thence with the rear line of Lots 33 and 32, N. 0-30 E. 51 feet to an iron pin at the joint rear corner of Lots 6 and 7; thence with the joint line of said lots, S. 81-40 W. 87.5 feet to an iron pin on the western side of First Avenue; thence with First Avenue, S. 0-30 W. 51 feet to the beginning corner;
