FOR AND IN CONSIDERATION of the sum of \$ 1.00 to the undersigned in hand paid by the City of Greenville, S. C., the receipt whereof being hereby acknowledged, (I) (we) hereby grant unto said City of Greenville, a right-of-way or easement along, over or under (my) (our) property for the purpose of:

Constructing a street through a parcel of land beginning at the east right-of-way of Elder Street near the intersection of Tuskegee Avenue at station 3/88, as shown on City of Greenville drawing #27-69, dated August 7, 1970, thence continuing in a southeasterly direction on an 8° curve to station 7/50.65 on the west right-of-way of Webster Road near the intersection of Allendale Lane. This right-of-way to include a strip of land 50 feet wide (25 feet on each side of the center line) as established and in accordance with aforementioned City of Greenville drawing.

This parcel of land being a portion of the Greenville Housing Authority tract between Elder Street and Webster Road.

Together with the right of ingress and egress for the purpose of inspecting and maintaining the same.

Said property is described as follows:

Located in the City of Greenville bounded on the west by Elder Street and on the east by Webster Road, also shown as a portion of Lot 1, Block 5, Sheet 199.2 on the County Block Book.

TO HAVE AND TO HOLD all and singular the right to the City of Greenville, S. C., its successors and assigns. And (we) (I) do hereby bind (ourselves) (myself), (our) (my) heirs, successors or administrators or assigns, to warrant and forever defend all and singular said premises unto the Grantee herein.
