Know All Men by These Presents:

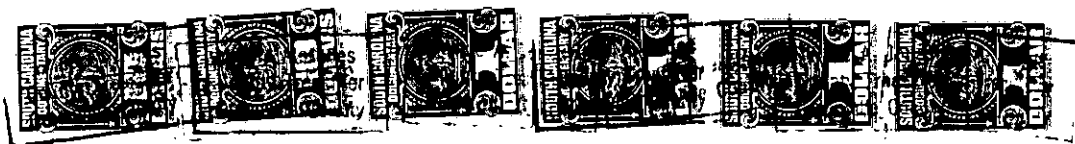

ALL that lot of land with the buildings and improvements thereon situate on the East side of Parkins Mill Road in the City of Greenville in Greenville County, South Carolina, being shown as Lot No. 7 on plat of Section "C" of Gower Estates made by R. K. Campbell, Surveyor, and Webb Surveying and Mapping Co., July 27, 1963, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book YY, Page 113, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Parkins Mill Road at the joint front corner of Lot 6 and 7 and runs thence along the line of Lot 6, N. 83-39 E., 250 feet to an iron pin; thence S. 11-34 E., 120 feet to an iron pin; thence along the line of Lot 8, S. 74-26 W., 249.8 feet to an iron pin on the East side of Parkins Mill Road; thence along Parkins Mill Road, N. 12-32 W., 80 feet to an iron pin; thence still along Parkins Mill Road, N. 8-30 W., 80 feet to the beginning corner.

Grantee assumes and agrees to pay that certain note and mortgage from Grantor to First Federal Savings and Loan Association, Greenville, South Carolina, which mortgage is recorded in the Office of the R.M.C. for Greenville County in R.E.M. Book 1145 at page 460, which mortgage has a present balance of \$38,355.51.
