unto JOSEPH L. SAUNDERS A. D. CAROL A. SAUNDERS, their heirs and assigns;

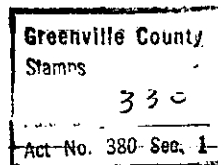
ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the County of Greenville, in Greenville Township, State of South Carolina, and being on the South side of Arlington Avenue (Formerly Carlin ton Street), in Ward Five of the City of Greenville, and being designated as Lot No. 5 in Block B, as shown on plat of Pendleton Street Realty Association, recorded in the R.C Office for Greenville County in Plat Book A, page 122 and page 123; and having, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Arlington Avenue 200 feet from the Southwest corner of Sumner Street and Arlington Avenue; thence along Arlington Avenue, N. 72-85 W. 50 feet to an iron pin, corner of Lot No. 6; thence with line of Lot No. 6, S. 15-15 W. 197 feet 8 inches to an iron pin; thence S. 72-85 E. 50 feet to an iron pin, corner of Lot No. 4; thence with line of Lot No. 4, N. 15-15 E. 196, back to beginning corner on Arlington Avenue.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record on the recorded plat(s) or on the premises.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to First Federal Savings & Loan Association, on which there is a balance due of \$ 12,000.00 : said mortgage being recorded in Mortgages Volume 1135 .
