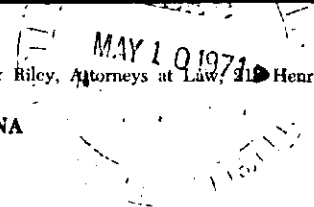

KNOW ALL MEN BY THESE PRESENTS, that Wigfall Satterwhite and Janie W. Satterwhite

in consideration of \$629.37 and assumption of mortgage set out below Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Wigfall Satterwhite, Jr. & Mary Satterwhite Brown, their heirs and assigns forever: All that piece, parcel or tract of land lying in the State of South Carolina, County of Greenville, and being one of the lots shown on a plat of property of J. R. Richardson, Sr., prepared by C. O. Riddle, Surveyor, dated August 28, 1964, being recorded in the RMC Office for Greenville County in Plat Book III, at page 57, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the corner of Rachel Sweet property, and running thence N. 15-45 W., 396 feet to an iron pin on the side of a branch; thence with the branch as the line, N. 88-12 W., 55.3 feet to an iron pin on said branch, thence S. 11-20 E., 124.1 feet to an iron pin at the corner of lot conveyed to Jack Wright Satterwhite; thence with the line of said lot S. 17-04 E. 278.9 feet to a point on the line of L. R. Richardson property; thence N. 84-16 E. 56.8 feet to the point of beginning.

This is the same property conveyed to the grantors by deed of Simpsonville Methodist Church.

ALSO: A right-of-way for ingress and egress over a gravel road which leads from the above property to Cook Street, as will more fully appear by reference to the deed of L. R. Richardson, recorded in the RMC Office for Greenville County in Deed Book 769, at page 362.

As a portion of the consideration herein the grantees assume and agree to pay the balance due on that certain note and mortgage in favor of Fountain Inn Federal Savings and Loan Association, recorded May 7, 1965, in REM Volume 994 at page 15 in the RMC Office for Greenville County.
