KNOW ALL MEN BY THESE PRESENTS, that WE, HENRY DAVIS and JESSIE DAVIS

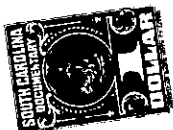
in consideration of Ten and No/100 (\$10.00) and other valuable consideration-----Dollars the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Clarence Sylvester Bowens, his heirs and assigns forever:

ALL our right, title and interest in and to all that certain piece, parcel or lot of land with all improvements thereon situate, lying and being on the Northern side of Worley Road, in the County of Greenville, State of South Carolina and having according to a survey of the said property made by Jones Engineering Services on March 9, 1971, the following description, to-wit:

BEGINNING at an iron pin on the Northern side of Worley Road at the joint front corner of the lot described herein and property now or formerly belonging to Bowen, which point is 263.6 feet in a westerly direction from the northwestern corner of the intersection of Worley Road and Thrift Street; thence along Worley Road N. 68-21 W. 80 feet to an iron pin on an 18 foot driveway; thence along said driveway N. 15-16 E., 213.4 feet to an iron pin; thence S. 57-30 E., 120 feet to an iron pin on Bowens line; thence S. 25-55 W., 190 feet to an iron pin, the beginning corner.

This is a portion of the property conveyed to James Davis by deed of Annie M. Turpin on January 14, 1907, which deed is recorded in the RMC office for Greenville County in Deed Book TTT, page 468, and later conveyed by James Davis to James Butler Davis on March 7, 1908 which deed is recorded in the RMC office of Greenville County in Deed Book ZZZ, page 47. The grantors herein are the heirs at law of the said James P. Davis who died testate a resident of Greenville County on September 28, 1954 as will appear by reference to the records of the Probate Court for Greenville County, South Carolina, Apartment 958, File 18, and is hereby conveyed subject to all easements, restrictions, rights of way or encumbrances appearing of public record or actually showing on the grounds.
