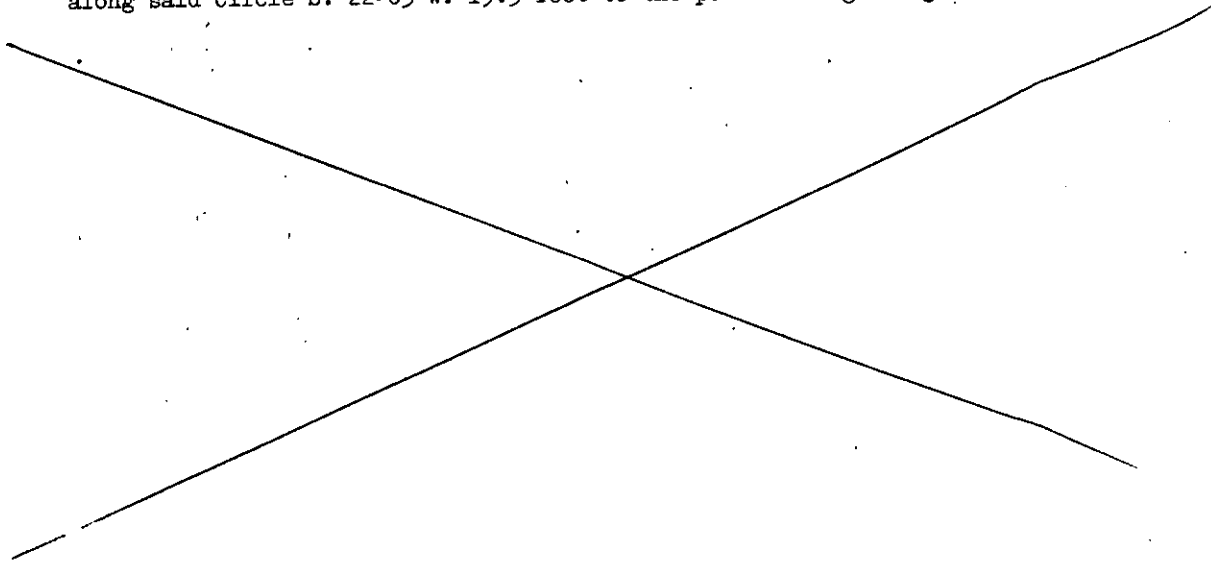

Deed for South Carolina

KNOW ALL MEN BY THESE PRESENTS, **GEORGE ROMNEY**, Secretary of Housing and Urban Development, of Washington, D. C., acting by and through the Federal Housing Commissioner, (hereinafter referred to as "Grantor"), for and in consideration of the sum of ELEVEN THOUSAND THREE HUNDRED-----DOLLARS (\$11,300.00-----), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto **PHILLIP H. PRYOR & PHYLLIS H. PRYOR**

(hereinafter referred to as ("Grantee(s)"), and to the heirs and assigns of said Grantee(s), the following described real estate situate in the County of **GREENVILLE**, State of South Carolina, to wit:

All that piece, parcel or lot of land situated in the County of Greenville, State of South Carolina, in and adjacent to the City of Greenville, on the western side of Monteith Circle and being known and designated as Lot No. 9 on plat of property of O.Y. Brownlee, H.C. Smith and C.S. Fox recorded in the R.M.C. Office for Greenville County in Plat Book "Q", at Page 164, and having, according to said plat, the following metes and bounds, to-wit: Beginning at an iron pin on the western side of Monteith Circle at the joint front corner of Lots Nos. 8 and 9 and running thence along the joint line of said lots N. 85-57 W. 168.4 feet to an iron pin; thence N. 12-44 W. 35 feet to an iron pin; thence along the joint line of Lots Nos. 9 and 10 N. 83-36 E. 145 feet to an iron pin on the western side of Monteith Circle; thence along said Circle S. 28-47 E. 50.5 feet to an iron pin; thence continuing along said Circle S. 22-05 W. 19.5 feet to the point of beginning.



BEING the same property acquired by the Grantor pursuant to the provisions of the National Housing Act, as amended (12 USC 1701 et seq.) and the Department of Housing and Urban Development Act (79 Stat. 667).

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise appertaining or incident.

TO HAVE AND TO HOLD all and singular the premises before mentioned, unto the said Grantee(s), and to the heirs and assigns of said Grantee(s) forever.

SUBJECT to all covenants, restrictions, reservations, easements, conditions and rights appearing of record; and SUBJECT to any state of facts an accurate survey would show.
