ALL water lines, mains, valves and appurtenances installed and located in, under or along Winsford Drive, Wallingford Road, Norwich Drive, Bexhill Court, Crestwood Drive, Bromsgrove Drive, Dronfield Drive, Garden Terrace and Hillandale Circle, County of Greenville, State of South Carolina, including approximately 5,000' more or less of 6" C.I. Pipe, 3,150' more or less of 2" galvanized pipe, 6 fire hydrants, 13 6" valves, 1 6" tap valve, 1 6" pressure reducing valve, 1 2" pressure reducing valve, and 13 2" gate valves and is shown on a drawing entitled "Dan Bruce, ET'AL to City of Greenville," attached hereto and made a part of this conveyance.

TOGETHER with all other mechanical parts and equipment appurtenant to said lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water lines and appurtenances.
