All our undivided two-thirds (2/3) interest in and to:

All that certain piece, parcel or tract of land in Greenville County, State of South Carolina, being known and designated as Tract No. 3 on plat of property of Boyce, Peden and Hartsell, prepared by C. O. Riddle, dated April 1971 and having according to said plat, the following metes and bounds, to wit:

BEGINNING at a railroad spike in center of Hipps Road, which spike is located N. 83-06 W., 16.9 feet from old iron pin on the Easterly side of said road and running thence S. 83-06 E., 512.1 feet to old iron pin; thence S. 2-42 W. 598.4 feet to an old iron pin; thence S. 81-40 W., 877.9 feet to a point in center of Hipps Road, passing over iron pin 32.4 feet back on line; thence with the center of Hipps Road N. 33-12 E., 537.4 feet to pin; thence N. 28-42 E., 100 feet to bend; thence N. 15-09 E., 100 feet to a bend; thence N. 5-26 W., 149.6 feet to the beginning corner, containing 9.79 acres, more or less.

This property is a portion of Tract No. 3 of the J. P. Hipps property, prepared by W. J. Riddle, in July 1925. This property was divided under the terms of Item 6 of the J. P. Hipps Will to Herman Rector Hipps for life and then to go to the children of Herman Rector Hipps. Herman Rector Hipps is deceased and the grantors and grantee herein are his only children.
