in consideration of Twenty thousand nine hundred and no/100-----(\$20,900.00)---Dollars,

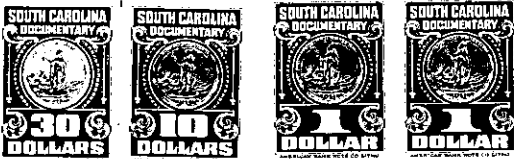

ALL That lot of land situate on the southwestern side of Dogwood Lane in the county of Greenville, state of South Carolina, being shown as property of Holloway Builders on plat dated July 22, 1970, prepared by Campbell & Clarkson, Surveyors, recorded in the RMC Office for Greenville County, and having, according to said plat, the following metes and bounds:

BEGINNING At an iron pin on the southwestern side of Dogwood Lane, which pin is N. 41-05 W. 10 feet from the northwestern side of a 15-foot alley and running thence with the center line of Dogwood Lane, N. 41-05 W. 100 feet to an iron pin; thence S. 55-02 W. 250 feet to a point; thence with a new line, S. 41-05 E. 100 feet to an iron pin at corner of a 10-foot strip; thence with said strip, N. 55-02 E. 250 feet to the point of beginning. See plat recorded in Plat Book 4I at Page 27 in the R.M.C. Office for Greenville County. This is the same property conveyed to the Grantor by deed recorded in Deed Book 908 at Page 25 in the RMC Office for Greenville County.

This property is conveyed subject to all restrictions, easements and conditions affecting said property.
