WILLIAM WRIGHT: --

All that piece, parcel or lot of land situate, lying and being 199.2 feet from the Northwestern side of Laurel Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a portion of Lot No. 14 as shown on a plat entitled Property of Central Realty Corp., prepared by W. J. Riddle, Registered Surveyor, dated June 30, 1950, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book Y at pages 84 and 85, and being known and designated as Lot No. 2 as shown on a more recent plat entitled Property of Alfred Wright and William Wright prepared by Jones Engineering Service, dated April 8, 1971, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 4 K at page 39, and having according to said more recent plat the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of a drive and utility easement at the joint front corner of Lots Nos. 1 and 2, said iron pin being 199.2 feet from the Northwestern side of Laurel Drive and running thence with the Eastern side of said drive and utility easement N. 30-00 W. 90 feet to an iron pin; thence N. 60-00 E. 175.3 feet to an iron pin; thence S. 22-24 E. 100 feet to an iron pin at the joint rear corner of Lots Nos. 1 and 2; thence with the line of Lot No. 1 S. 62-26 W. 162.8 feet to the point of beginning.

The above-described property is a portion of property conveyed to the grantor herein by deed of Central Realty Corp., dated January 26, 1952, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 450 at page 179 on January 29, 1952.

This conveyance is subject to all restrictions, zoning ordinances, setback lines, roadways, easements and rights of way, if any, affecting the above-described property.
