KENNETH E. RIDDLE and SNADRA F. RIDDLE, their heirs and assigns forever:

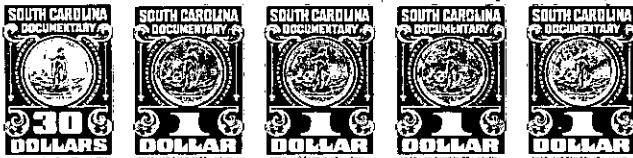
