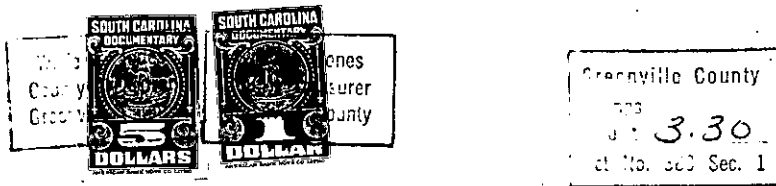
KNOW ALL MEN BY THESE PRESENTS, that Jackie Wendell Smith and Jacquelyn H. Smith -----
