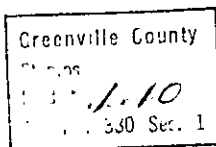
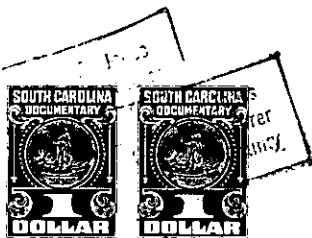
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

All that piece, parcel or lot of land lying, being and situate in the County and State aforesaid and in the Town of Fountain Inn, in the subdivision known as Friendship Heights, designated on a plat of the same as Lot No. 13 in Block B, and having according to said plat the following courses and distances, to-wit:

BEGINNING at an iron pin on the Northwest side of Hellams Street, joint front corner with Lot No. 14 on said Street and running thence with the joint line of said Lot No. 14, N. 86-30 W. 150 feet to an iron pin, back joint corner with said Lot No. 14 on line of Lot No. 15; thence with the joint line of said Lot No. 15, N. 3-30 E. 80 feet to an iron pin, joint corner with said Lot No. 15 and Lot No. 12; thence with the joint line of said Lot No. 12, S. 86-30 E. 150 feet to an iron pin on Northwest side of said Hellams Street, and joint front corner with Lot No. 12; thence with the Northwest side of said Hellams Street, S. 3-30 W. 80 feet to an iron pin, the point of beginning, and bounded by said Hellams Street, Lots Nos. 14, 15, and 12.
