in consideration of One Thousand Six Hundred and No/100 (\$1,600.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Audry L. and Wanda L. Rinehart, their heirs and assigns forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 59, as shown on a plat of Pinewood Estates by H. S. Brockman, Surveyor, dated November 1958 and recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 55, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Earlene Drive, joint front corners of Lots Nos. 58 and 59 and running thence along the line of said lots, S. 88-05 W. 170 feet to iron pin; thence running with rear line of Lot 59, S. 1-55 E. 92 feet to iron pin rear corner of Lot 60; thence running with line of said lot N. 88-05 E. 170 feet to iron pin on Earlene Drive; thence running with Earlene Drive, N. 1-55 W. 92 feet to iron pin point of beginning.

No residence to cost less than Ten Thousand (\$10,000.00) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than thirty-five (35) feet to the front line; no residence shall be built on any lot unless said lot has seventy (70) feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes only.

THIS conveyance is subject to all easements and rights of way of record.
