KNOW ALL MEN BY THESE PRESENTS, that I, Frances S. Crosby, Teresa Crosby Cason, & Samuel E. Crosby

in consideration of One Dollar (\$1.00), Love and Affection-----XXXXXXXX the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Teresa C. Cason and William A. Cason, their heirs and assigns forever:

ALL that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, being known and designated as the property of Teresa C. Cason and William A. Cason as shown on a plat thereof prepared by Carolina Engineering and Surveying Company on November 12, 1970, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the intersection of a County Road and Mill Road and running thence S. 4-19 E. 710 feet; thence N. 85-41 W. 496.6 feet to an iron pin; thence N. 29-48 W. 327 feet to an iron pin; thence N. 82-37 E. 760.4 feet to an iron pin, the point of Beginning.

This property is subject to the following restrictions which shall run with the land for a period of twenty (20) years from the date hereof:

1. No dwelling shall be constructed on the property herein described containing less than 1,500 square feet exclusive of breezeway, carports or garages.
2. No mobile home or trailer shall be placed on said property.
3. This property shall be used for residential purposes only.

This conveyance is made subject to any and all existing reservations, easements, rights of way, zoning ordinances, and restrictions or protective covenants that may appear of record, on the recorded plat(s) or on the premises.

This deed is a correction deed executed to correct the scrivener's error in the deed from the same grantors to Teresa C. Carson and William A. Carson dated December 21, 1970 and recorded in the R. M. C. Office for Greenville County in Deeds Book 906 at Page 295; the scrivener's error being the addition of the letter "r" showing the name to be Carson rather than Cason.
