unto James P. Coleman, III and Mary R. Coleman, their heirs and assigns forever:

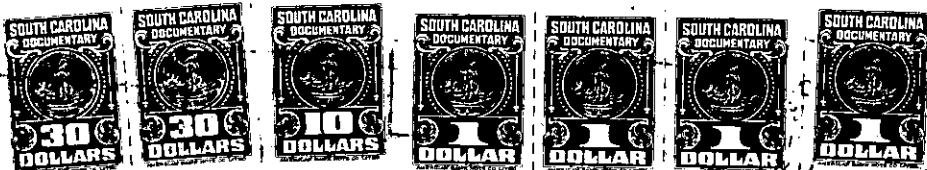
