the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Doris H. Taylor, her heirs and assigns,

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, county of Greenville, near the city of Greenville, being known and designated as Lot No. 172 of a subdivision known as Pine Hill Village as shown on plat prepared by R. K. Campbell, R.L.S. November 30, 1960, and recorded in the RMC Office for Greenville County in Plat Book QQ at page 168, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of West Castle Road, joint front corner of Lots 171 and 172; running thence with the joint line of said lots, N. 66-14 W. 130 feet to an iron pin at the joint rear corner of Lots 171 and 172; thence with the rear line of Lot 172, S. 23-46 W. 70 feet to an iron pin at the joint rear corner of Lots 172 and 173; thence with the joint line of said lots, S. 66-14 E. 130 feet to an iron pin on the western side of West Castle Road, joint corner of Lots 172 and 173; thence with the western side of West Castle Road, N. 23-46 E. 70 feet to the point of beginning.

This is the same lot conveyed to grantor by William E. & Josephine M. Clark by deed recorded June 1, 1971 in vol. 916 page 547 of the RMC Office for Greenville County, S. C., and is conveyed subject to recorded restrictions, easements and rights of way or those shown on the ground.

As a part of the consideration for this conveyance, the grantee assumes and agrees to pay that certain mortgage given to C.
