Lee Dillard, his successors and assigns, an undivided one-sixth interest in and to that certain piece, parcel or lot of land located in Chick Springs Township, Greenville County, State of South Carolina, and being shown on a plat of C. F. James Estate and Mrs. C. F. James prepared by Terry T. Dill, January 15, 1958, and according to said plat which is recorded in the R.M.C. Office for Greenville County in Plat Book "KK" at page 111; having the following metes and bounds, to-wit:

BEGINNING at an iron pin at joint corners of F. Outerbridge, E. Jones and Mrs. C. F. James (formerly), and running thence N. 16-50 E. 735 feet to an iron pin; thence N. 59-12 W. 400 feet to the Old Spartanburg Road; thence N. 34-15 E. 1,000 feet; thence along said road N. 34-35 E. 321 feet to property of School District 520; thence with said road N. 36-30 E. 178 feet; thence still with said road N. 40 E. 106.3 feet to property of Brushy Creek Church; thence along property line of Brushy Creek Church S. 37-10 E. 128.5 feet to an iron pin; thence S. 35 E. 622 feet to an iron pin; thence S. 11-15 W. 569.4 feet to an iron pin; thence across a branch S. 1-15 W. 495 feet to an iron pin; thence with said branch S. 19 W. 412.5 feet to an iron pin; thence on the east side of said branch S. 26 W. 240.2 feet to a poplar on the west side of said branch; thence across said branch S. 13 W. 495 feet along lands of J. Bramlett to an iron pin at Brushy Creek; thence with Brushy Creek N. 55-30 W. 500 feet to an iron pin; thence still with Brushy Creek S. 48 W. 150 feet to land of E. Jones; thence N. 32 W. 425 feet to the point of BEGINNING, being, according to said plat, 51.3 acres, more or less.
