KNOW ALL MEN BY THESE PRESENTS, that Robert D. Henderson and Carole T. Henderson -----

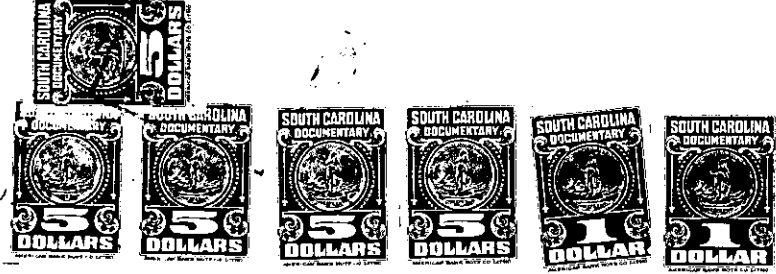
in consideration of Thirteen Thousand Two Hundred Fifty and No/100 (\$13,250.00) ----- Dollars,
