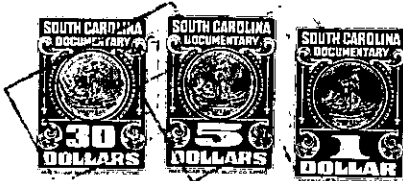
in consideration of Eighteen Thousand (\$18,000.00) Dollars,

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 23 of a subdivision of the property of Lanco, Inc. as shown on plat prepared by R. K. Campbell and Webb Surveying & Mapping Co., October 1963, and recorded in the RMC Office for Greenville County in Plat Book RR at page 199, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Malone Street, joint front corner of Lots Nos. 22 and 23, and running thence along the western side of Malone Street, N. 25-27 W. 70 feet to an iron pin at the corner of Lot No. 24; thence along the line of that lot, S. 66-04 W. 219.1 feet to an iron pin; thence S. 11-45 E. 70 feet to an iron pin at the rear corner of Lot No. 22; thence along the line of that lot N. 66-40 E. 235.4 feet to the beginning corner.

This is the same lot conveyed to grantor by Ward S. Stone by deed recorded Nov. 25, 1969 in deed vol. 880 page 75 of the RMC Office for Greenville County, S. C., and is conveyed subject to restrictions as recorded in deed vol. 771 at page 223, and to any recorded easements and rights of way of record or shown on the plat or on the ground.
