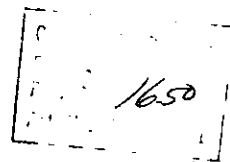
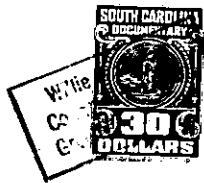

All that piece, parcel or lot of land in the County of Greenville State of South Carolina, City of Greenville, situate, lying and being on the northern side of Kirkwood Lane being known and designated as Lot No. 164 on a plat of Isaqueena Park recorded in the RMC Office for Greenville County in Plat Book P at Page 130 and 131 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Kirkwood Lane at joint front corner of Lots 163 and 164 and running thence along the line of Lot 163, N.6-29 W. 175 feet to an iron pin; thence N.83-26 E. 113.7 feet to an iron pin; thence along the line of Lot 165, S.9-31 W. 175 feet to an iron pin on the northern side of Kirkwood Lane; thence with the curve of Kirkwood Lane (the chord being S.84-24 W., 36.3 feet) to an iron pin; thence continuing with the curve of Kirkwood Lane (the chord being S.69-37 W., 30.7 feet) to the beginning corner.

This conveyance is made subject to such easements, rights-of-way and restrictions as appear on record or on the premises.
