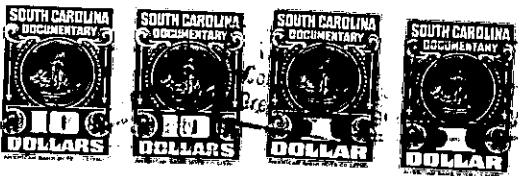

McCall hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee

All that piece, parcel or lot of land situate on the easterly side of Southland Avenue, City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 2 on plat of property of E. D. Sloan, prepared by Dalton & Neves in June 1955, revised March 1958, said revised plat recorded in the office of the R.M.C. for Greenville County in Plat Book KK, Page 137, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Southland Avenue at the joint front corner of Lots 2 and 3 and running thence along the joint line of said Lots N. 63-50 E. 200 feet to an iron pin in rear line of Lot 10; thence turning and running along the rear line of Lots 10, 11 and 12 N. 26-10 W. 125.4 feet to a point, joint rear corner of Lots 1 and 2; thence turning and running S. 63-50 W. 200 feet to an iron pin on the easterly side of Southland Avenue, joint front corners of Lots 1 and 2; thence turning and running along the easterly edge of said Avenue S. 26-10 E. 125.4 feet to the point of beginning.

This deed is made subject to any restrictions, rights-of-way, easements or agreements affecting the property that may appear of record, on a recorded plat, or on the premises, or that are known to the grantees.
