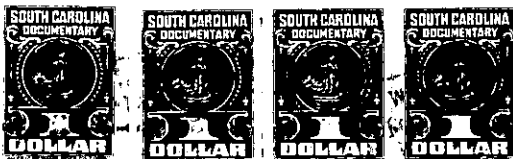
KNOW ALL MEN BY THESE PRESENTS, that We, Donald Martin Haas and Mary Shreve Haas

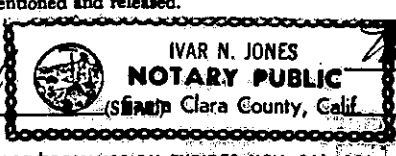
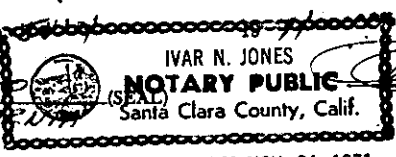
