the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto KATHLEEN G. KILGORE, HER HEIRS AND ASSIGNS FOREVER:

ALL my right, title and interest which I have inherited from my father, Melville C. Kilgore, Sr. in and to:

ALL that piece, parcel or lot of land in Chick Springs Township, County of Greenville, State of South Carolina, being four miles north of the City of Greenville on the northeast side of Lee Road, near Paris Station, and having according to a survey and plat by H. S. Brockman, Surveyor, made December 29, 1937, in part, the following metes and bounds, to wit:

BEGINNING at a point on the northeast side of said Lee Road at the corner of Grace Diver's property and running thence N. 16-18 E. 382.8 feet along the northeast line of said Diver's property to a point in the line of property now or formerly belonging to W. F. Roe; thence N. 74-25 E. 253.8 feet along the line of said Roe property to an iron pin at the corner of property now or formerly belonging to L. F. Gravitt; thence S. 20-00 W. 515 feet along the line of the Gravitt property to a point on the northeast side of Lee Road; thence N. 73-42 W. 184.4 feet along the northeast side of said Lee Road; to the point of beginning, containing 1.95 acres, more or less.
