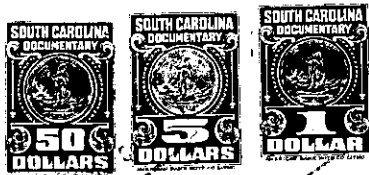
in consideration of Twenty Seven Thousand, Nine Hundred and No/100 (\$27,900.00)-----Dollars,
