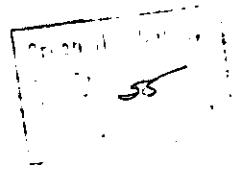
KNOW ALL MEN BY THESE PRESENTS, that We, Tommy M. Fisher and Charles R. Fisher,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto

Kaye Wooten Solesby, his Heirs and Assigns forever,

All that certain Piece, parcel or lot of land situate, lying and being
in the State and County aforesaid, Highland Township, Lying on the
West side of the Greer-Gowansville Road (also known as Wingo Road) and
being a part of the same land conveyed to us by deed from Woodrow J.
Wooten September 1st 1960, recorded in the office of the R. M. C. for
Greenville County in Deed Book 653 at page 102, and having the follow-
ing courses and distances, to wit:-

BEGINNING on a point in the center of the said road, joint corner of the
Two and Six Tenths acres lot, and runs thence with the western line of
the said lot, S. 61-18 W. 191 feet to an iron pin; thence with another
line of the 2.6 acres lot, S. 35-18 W. 88 feet to an iron pin; thence
a new line, N. 33-12 W. 113.5 feet to an iron pin; thence N. 61-18 E.
282.5 feet to a nail and cap in the center of the said road; thence
with the center of the road, S. 26-00 E. 75 feet to the beginning corner,
containing Fifty One One-hundredths (0.51) of one acre, more or less.
