in the State of South Carolina for and in consideration of the

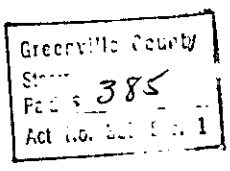
sum of Three Thousand Seventy-Five and No/100-----dollars,
