unto John Edward Thomas, Jr. and Lee de Lashmutt Thomas, their heirs and assigns forever:

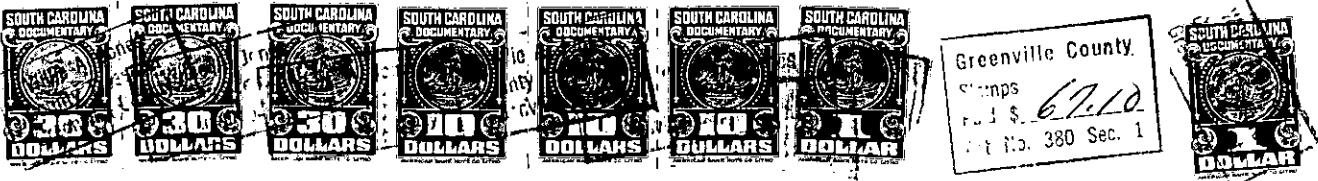
All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the westerly side of Cleveland Street Extension, in the City of Greenville, S. C., being known and designated as Lot No. 2B on plat entitled "Revision of Lot 2, Section E, Gower Estates" as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4E, page 71 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Cleveland Street Extension, said pin being the joint front corner of Lots 2B and 2A and running thence with the westerly side of Cleveland Street Extension S 9-19 E 90 feet to an iron pin; thence S 46-26 W 84 feet to an iron pin; thence S 62-56 W 220 feet to an iron pin; thence turning and running N 27-18 W 165.15 feet to an iron pin, the joint rear corner of Lots 2B and 2A; thence with the common line of said lots N 72-42 E 332 feet to an iron pin, the point of beginning.
